SUFFOLK COUNTY COUNCIL (DISTRICT OF ST EDMUNDSBURY) (STOPPING, WAITING AND LOADING PROHIBITIONS AND RESTRICTIONS AND ON-STREET PARKING PLACES) (MAP-BASED) ORDER 2019 (BURY ST EDMUNDS) (TAYFEN ROAD) (A1302) (PROHIBITION OF WAITING) (VARIATION NO.9) ORDER 202-

Suffolk County Council proposes to make the above order under Sections 1(1) and (2), 2(1) to (3) 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, which would substitute revision 3 of Map Tile DZ62 in place of revision 2 of the same Map Tile, and revision 4 of the Map Tile DY62 in place of revision 3 of the same Map Tile, into the above named 2019 Order. The effect of this would be to introduce:

- A 'no waiting at any time' restriction on both sides of the Tayfen Road (A1302) developer access road. This access road is located 54 metres north-east from the junction with St Andrews Street North (C757). The restrictions will extend 5 metres on both sides from the access road's junction with Tayfen Road in a north-westerly direction; and
- The existing 'no waiting at any time' restriction on Tayfen Road (A1302) will be amended. Currently, this restriction applies from a point 8 metres northeast of the centre of the junction with St Andrews Street North, extending 50 metres in the northeast direction on its north side, as well as from the same point for 33 metres on its south side. The new restriction will be 'no waiting at any time' and 'no loading/unloading at any time' on both sides of Tayfen Road (A1302), starting from a point 8 metres northeast of the junction with St Andrews Street North and extending 30 metres in the northeast direction.

Exemptions to the waiting restrictions allow a vehicle to wait for so long as is necessary to board or alight or to load and unload; for building, industrial or demolition works; for the maintenance of the road or its services; for emergency services, and for fulfilling statutory duties. There are the usual exemptions for blue badge-holders.
