Ukraine Permission Extension Scheme – (UPES): A Guide for Ukrainians in the UK

The UK Government has introduced the Ukraine Permission Extension scheme (UPES). The scheme allows people currently living in the UK under an existing Ukraine Visa scheme to apply to extend their stay in the UK for a further 18 months when their valid Ukrainian visa expires.

The Ukraine Permission Extension Scheme (UPES) is now open for applications.

It is free to apply for the UPE scheme, and if an application is successful, your guests will be able to continue to live, work and study in the UK and access public funds.

It is important that your guests actively apply to extend their visa. (Please note –visas Will NOT be extended Automatically).

How and when to apply?

- Your guests should submit an application when they have 28 days or less left on their current permission.
- If your guest applies too early, their application may be rejected and would then need to reapply when their current permission has 28 days or less remaining.
- If your guest doesn't know the date when their current leave to remain ends, they can sign into their <u>UKVI account</u> to find out or refer to their permission letter to verify the visa's expiry date.
- Applications can only be submitted while your guests are physically present in the UK.

Please note:

- Your guests should not leave the UK while their UPE application is being processed. Leaving the country will result in the cancellation of an application.
- Transitioning to an e-Visa is not the same as extending a visa under the UPE.

Children being sponsored by a parent or legal guardian: Homes for Ukraine

As of 31 January 2025, a parent (or legal guardian) who holds permission under any of the Ukraine Schemes can apply to sponsor their child.

Children sponsored by their parents (or legal guardians) will hold permission to live in the UK for up to 18 months. They will have access to education, healthcare, benefits and employment (as appropriate under UK law).

Please note that a parent or legal guardian who is sponsoring their child will not qualify for thank you payments.

Council Tax Disregard – Ukraine Permission Extension

Ukraine Permission Visa Holders are disregarded for the purpose of council tax only if they live in accommodation provided by a sponsor/host who is entitled to 'thank you payments' under Ukraine Permission Extension, and they previously held a Homes for Ukraine visa.

E-Visa Roll out

The Government is urging all those across the UK who use a physical immigration document to take immediate action to transition to an e-Visa, as part of plans to digitise the UK border and immigration system.

If you have Homes for Ukraine guests, please ensure they are progressing their application to move to an e-visa'

E-visa will need to be in place if guests wish to apply for a Ukraine Permission Extension scheme visa when they are eligible.

All visa holders who live in the UK and use a physical immigration document, such as a Biometric Residence Permit (BRP), to prove their rights are urged to take action now at Get access to your eVisa: Overview - <u>Online immigration status (eVisa) - GOV.UK</u>

Ukrainian guests are asked to retain their BRP – as this will help with a smooth customer experience to apply for the Visa Extension Scheme.

eVisa Help and Support

Help is available for those who need support to transition from using physical immigration documents to eVisas:

- Charities and voluntary organisations across the UK are also able to provide free help and information to vulnerable people who need to create a UK Visas and Immigration (UKVI) account and access their eVisa. Seasonal Winter 'Thank you' payment.

Suffolk County Council is offering a one-off additional payment of £330 to all hosts who are accommodating Ukrainian guests during the month of January 2025, in recognition of the additional financial pressures faced during our coldest months.

You do not need to make a claim for this payment. An email was sent to eligible hosts in January 2025 advising they will receive the payments and giving the option to opt out if they choose.

This payment will be made in February to those hosting Ukrainian guests during January 2025 and is in addition to the monthly payment already paid to active hosts on this scheme.

Thank You Payments Update

Following the recent updates from central government, where it was announced that all 'thank you' payments will be paid at a flat rate of \pounds 350, we are pleased to provide the following update:

Hosts whose guest/s remain on their existing homes for Ukraine visa

Suffolk County Council will fund an increase to the rate of the government monthly thank you payment of 25. Therefore, the standard payment rate to all eligible hosts will be 375.

Suffolk County Council will uplift with an additional £150 per month once hosts have been hosting their guest(s) for at least 6 months - £375 + £150 making a total monthly payment of £525. Sponsors/ hosts will be asked to opt-in to the additional payment as part of the thank you payment claims.

If sponsors/ hosts do not opt-in to receive the uplift, they will receive the standard payment rate for the duration of the hosting period (payments will not be increased when guest has been in the UK for 12 months)

As per new guidance issued by central government, all existing sponsors/ hosts will be asked to complete a new thank you payment claim during April 2025 for payments to be made from May 2025, which will cover the month of April.

A claim will be required for each individual accommodation where guests are being hosted (i.e. We cannot accept a single claim from a sponsor/ host to cover multiple accommodations/set of guests).

Government eligibility criteria for sponsorship and receiving thank you payments in place at the time of the claim will be applied. This may result in some existing thank you payment recipients no longer being eligible to receive payment e.g. In situations where a close family member is being hosted.

Independent Living Payment

Suffolk County Council is offering a one-off Independent Living Payment (ILP) of £2,000 to Homes for Ukraine guests and are leaving their host accommodation and moving into their own home. To issue this payment certain criteria must be met, and Suffolk County Council will ask to see a copy of a valid, signed and dated (by both parties) legal tenancy agreement in the guest's name.

The funding can be used for purchasing items to support the move to independent accommodation. The new accommodation can be either furnished or unfurnished and can be situated outside of Suffolk.

Could you help a family in need?

In February 2022, the UK was asked to help support Ukrainians displaced by the war. Since then, the people of Suffolk have welcomed more than 1,400 Ukrainian Refugees into their homes.

Unfortunately, the war continues, and we still need hosts to offer a safe place to stay for individuals and families in Suffolk.

Can you help? Homes for Ukraine Suffolk still need safe and secure places in the larger villages and towns, with good access to public transport and amenities. If you can offer a safe place for a Ukrainian guest, please visit <u>Homes for Ukraine: record your interest</u> to express your interest by completing the online form. Accommodation must be available for at least 6 months and be fit for purpose.

If you sign up to the scheme and all checks are completed, you will be eligible for a monthly 'Thank you' payment.



Would you consider providing a safe home to a displaced person from Ukraine?

USPUK (Universal Sponsorship Pathway UK) is a registered charity and one of the government's <u>recognised providers</u> for sponsorship under the Homes for Ukraine scheme. USPUK's Ukrainian Sponsorship Project has been matching hosts to Ukrainian guests for the last two years. We have supported the resettlement of around 1000 displaced Ukrainians through the Communities for Ukraine programme. However, hundreds of Ukrainians still contact us every month looking for hosts, and these numbers are rising due to the deteriorating situation in Ukraine as winter approaches and the war continues.

USPUK's Ukrainian Sponsorship Project team includes native speakers of both English and Ukrainian. We have a rigorous safeguarding process to ensure the safety of both guests and hosts, and we are committed to supporting you in your journey to becoming a host.
