## Adult Social Care Finance Provider Portal – Notice for Care Home Providers

Further to our communication on 5<sup>th</sup> September 2024 (Care Market Update 267), we wanted to remind those of you who have are not already using Suffolk's Finance Portal that there are many positives to being able to access the system 24/7 as it will allow you to see active CPLI's (Care Package Line Items) with start dates, weekly rates and whether or not a customer is paying a contribution to their care. The system also enables you to see scheduled payments both current and historic and allows you to engage with FIAS via the portal removing the need to send emails. Those care homes already using this system are enjoying the benefits that it brings.

Once you have watched webinar, send a request to access the system to ACS Contracts Helpdesk <u>ACSContractsHelpdesk@suffolk.gov.uk</u> they will send you a small number of questions to answer to evidence that you have watched the video and are feeling confident in using the system.

If you answer all questions correctly, you will be issued with further details on how to access the portal after which you can access this as frequently as you wish. If you do not answer all the questions correctly first time around, please do not worry, watch the webinar again and then email the Helpdesk once more.

## WEST ONLY Payment Period 9 - Change of Payment Date
