The UK Health Security Agency (UKHSA) Visiting Principles in ASC Services

Update from Suffolk County Council

This guidance covers the principles to support decision making for those involved in safely planning and protecting visiting during outbreaks of infectious illness in adult social care.

This recently published guidance accompanies the <u>new legislation</u> on visiting and accompanying in care homes, hospitals and hospices. It aims to provide clarity to health protection teams, community infection control teams and care home managers and providers who have responsibility for implementing outbreak management measures in adult social care homes.

This document provides general principles to support advice and decision making along with a review of the issues which should be considered in safely planning visiting during outbreaks of infectious illness.
