Capacity Tracker - Planned System Downtime

Update from ADASS East of England

As part of our continuous improvement programme, we're making some performance enhancing changes to Capacity Tracker. To minimise disruption, these changes will take place over two weekends during which there will be periods when users cannot access the system. During the offline period, a user will be

presented with a maintenance page this will be removed when the system is reinstated, and users will be able to access the Capacity Tracker as usual.

The Capacity Tracker system will be unavailable between 10am - 6pm (BST) on the following dates:

Saturday 17th August 2024

Saturday 21st September 2024

In advance of these changes taking place, we would like to provide some recommendations to support you:

- Refresh your vacancy information on Friday 16th August and Friday 20th September
- •Download the reports you need the day before the changes take place (no later than 11:59pm on 16th August 2024 and 20th September)
