#### **Provider Incident Process**

Dear colleagues,

The Provider Incident Process was established in March 2024 to enable Providers to notify Adult Social care of incidents that have occurred but do not require a referral to Safeguarding.

This bulletin is a reminder of this process & how you can report an incident to Adult Social Care.

To report a Provider Incident, please click on the link below.

<u>Provider Incident Report Form for ACS Commissioned Providers (microsoft.com)</u> -> In some cases incidents may not be regarding individuals, in these cases please input 'N/A' into the mandatory service user boxes.

Please refer to the Suffolk Safeguarding Adults Framework & Raising a Safeguarding Concern Guidance attached prior to completing the Incident Report Form to ensure a Safeguarding is not required.

Once an Incident Report has been submitted, the details will be reviewed by ASC. If for any reason, ASC feel the Incident should be reported as a Safeguarding you will be informed and ask to submit a referral following the usual Safeguarding process.

### **Capacity Tracker - Planned System Downtime**

Update from ADASS East of England

As part of our continuous improvement programme, we're making some performance enhancing changes to Capacity Tracker. To minimise disruption, these changes will take place over two weekends during which there will be periods when users cannot access the system. During the offline period, a user will be presented with a maintenance page this will be removed when the system is reinstated, and users will be able to access the Capacity Tracker as usual.
