<u>Adult Care Providers requesting support for a Certificate of Sponsorship Licence, from Suffolk County Council</u>

Local authorities may support a care provider directly, with their certificate of sponsorship (COS) application to UKVI or for extensions to existing IR visas, by a letter from Suffolk County Council.

The reason behind this is that many local authorities have a framework approach rather than a specified number of hours or value of contract with care providers which makes it more difficult for the provider to meet the criteria for the COS.

To consider supplying a supporting letter, information is needed from the care provider, for example - regarding number of individuals previously supported with care packages; size and structure of their organisation and type of contracts being delivered.

This information then needs to be verified by the contract manager and approved by senior managers within the council. If approved the letter will be sent directly to UKVI and if not approved the care provider will be notified.

Please allow at least 10 days for this process to be completed.

Preventing Data Breaches: When referring into the Suffolk County Council (SCC) portal could we remind care home staff to only use their work email address. The use of a personal email address creates a data breach for both the care home and SCC. When such breaches occur, SCC have a duty to report all incidents to the Information Commissioner's Office (ICO). This is in line with The Data Protection Act 2018 and the UK GDPR. The ICO will determine the action to be taken on a case-by-case basis. Thank you for your cooperation in ensuring we safeguard everybody's data.

Suffolk County Council is committed to improving support for unpaid carers in our community. As part of this commitment, the **Suffolk All Age Carers' Strategy 2022-2027** (<u>View Here</u>) sets out several strategic objectives, including the recruitment and retention of unpaid carers in the workforce.

To further this goal, we are introducing a new **3-tiered program** called **'Caring Companies'**. This program offers organisations the opportunity to earn recognition at **Bronze**, **Silver**, and **Gold** levels, based on the support organisations embed within their practices and policies towards unpaid carers within their workforce.
