# Homes for Ukraine Scheme - Policy Changes on Thank you Payment and Eligibility and Unaccompanied Minors

The following policy changes have been announced by the Ministry of Housing, Communities and Local Government and came into effect on 1 October 2024:

- For all new applications for thank you payments (rematches and new arrivals), sponsors who
  are in (or form) a close family relationship with their guest will no longer be eligible for payment.
  The policy will not be applied retrospectively, any current arrangements where thank you
  payments have been approved and commenced prior to 1st October will continue.
- Unaccompanied minors (UAM) policy has been amended so that, where a local authority
  identifies a Ukrainian child already living in the UK with a close family member/s only, this will
  not be treated as a new Homes for Ukraine 'sponsorship' i.e. the child will not be classified as
  an unaccompanied minor.

#### E-Visa Roll out

The Government is urging all those across the UK who use a physical immigration document to **take immediate action to transition to an e-Visa**, as part of plans to digitise the UK border and immigration system.

If you have Homes for Ukraine guests, please ensure they are progressing their application to move to an e-visa'

All visa holders who live in the UK and use a physical immigration document, such as a Biometric Residence Permit (BRP), to prove their rights are urged to take action now at Get access to your eVisa: Overview - GOV.UK (<a href="www.gov.uk">www.gov.uk</a>)

#### **Independent Living Payment**

Suffolk County Council is offering a **one-off Independent Living Payment (ILP) of £2,000** to Ukrainian guests who are part of the Homes for Ukraine Scheme and are leaving their host accommodation and moving into their own home. In order to issue this payment certain criteria must be met, and Suffolk County Council will ask to see a copy of a valid, signed and dated (by both parties) legal tenancy agreement in the guest's name.

The funding can be used for purchasing items to support the move to independent accommodation. The new accommodation can be either furnished or unfurnished and can be situated out of Suffolk.

#### **Guests Leaving Hosts - reminder.**

This message serves as a brief reminder of your requirement to inform us as soon as your guests are no longer with you, because they have decided to go on holiday or move on from their current hosting arrangement.

This is to allow us to make payment adjustments if required and process final payments in a timely manner to reduce the likelihood of any under or overpayments. We also need to ensure the safety and well-being of all parties.

#### **Lead Host Declaration Reminder**

Sponsors/hosts of Ukrainian guests on a Homes for **Ukraine** visa are eligible for a monthly payment from the UK government as a thank you for hosting.

You do not have to apply for the Host "**Thank you**" payment (we will ask you at the initial telephone conversation with you if you would like to receive this payment) but if you do wish to receive this payment, Suffolk County Council is required, under the Government's terms of the scheme, to receive your agreement, and this is done by requesting that you complete our Declaration form.

When you first apply to sponsor a visa or be a rematch host for Ukrainian guests under the Homes for Ukraine scheme, we will email you new sponsor information, and also send an email to the Lead Host called 'Homes for Ukraine Lead Host Declaration'.

Please ensure that you complete the short online form sent in this email as soon as possible.

We will be unable to make monthly payments to you if we do not receive your completed initial declaration.

We will ask for the declaration to be agreed again at regular intervals throughout your hosting journey. If you have any questions regarding this, please email - refugeesupport@suffolk.gov.uk

# Could you help a family in need?



In February 2022, the UK was asked to help support Ukrainians displaced by the war. Since then, the people of Suffolk have welcomed more than 1,400 Ukrainian Refugees into their homes.

Unfortunately, the war continues, and we still need hosts to offer a safe place to stay for individuals and families in Suffolk.

Can you help? Homes for Ukraine Suffolk still need safe and secure places in the larger villages and towns, with good access to public transport and amenities. If you can offer a safe place for a Ukrainian guest, please visit <a href="Homes for Ukraine: record your interest">Homes for Ukraine: record your interest</a> to express your interest by completing the online form. Accommodation must be available for at least 6 months and be fit for purpose.

If you sign up to the scheme and all checks are completed, you will be eligible for a monthly 'Thank you' payment.
