This support is for churches preparing for a major project and developing their project to the point at which they can approach a major grant funder. Grants will never exceed 50% of the net project costs for this phase.  The National Churches Trust's Medium Grants Programme can now offer grants of up to £10,000 for urgent and essential maintenance and repair projects costing between £20,000 and £80,000.
